Sir/Madam,

I am hereby directed to inform that the Competent Authority has accorded approval for extension of additional 43 drugs/medicines in DG-ESIC Central Rate Contract Nos. 142C,143C,144C,145C and 146C upto 31.10.2024 or till the finalization of New Rate Contracts, whichever is earlier, (List of 43 drugs enclosed) on the same Terms & Conditions and approved Rates of DG-ESIC RC 142C to 146C, subject to adherence to the following conditions: -

1. Supply order should be placed **ONLY on First Preference Holders**.
2. Willingness of the firm to supply on the same Terms & Conditions, as approved in DG-ESIC Rate Contract(s) 142C,143C,144C,145C and 146C.
3. No order should be placed in respect of drugs, which have been found to be "Not of Standard Quality" on test analysis.
4. Amendments/ orders (if any) already issued in DG-ESIC Rate Contract(s) 142C,143C,144C,145C and 146C have to be taken into consideration while placing the supply orders.

Procurement of rest of the drugs which were approved in DG-ESIC Rate Contract(s) 142C,143C,144C,145C & 146C and for which extension has not been accorded should be procured as per Public Procurement guidelines of Govt. of India giving due diligence to GoI initiative for make in India and as per instructions issued earlier by ESIC Hqrs.
