for service under Employees' State Insurance Corporation.

Their appointment is provisional and is subject to verification of the Character & Antecedents, educational qualification, caste certificates and other information being verified through the proper channels and if the verification reveals that the information/ certificates provided by the official is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such action as may be taken under the provisions of the Bhartiya Nyaya Sanhita for production of false information.

They should also inform about the change, if any, of their religion to their appointing / administrative authorities immediately after such a change. All other terms & conditions of appointment as communicated to them vide offer of Appointment Memorandum shall remain the same.
