Advertisement Recruitment for the Post of Junior Residents in Dentistry Department

ESIC Medical College & Hospital Faridabad proposes to engage Junior Residents against GDMO(Dental) on contract basis for a period of 6 months/1 year in the Department of Dentistry. The details of the vacancy and reservation position is as mentioned below:

It is informed that out of 4 vacant posts of Junior Residents (against GDMO), candidates will be selected for a tenure of up to 6 months (2 posts, which will be vacated as the appointed ESIC-JR joins) and 1 year (2 posts) terminable with a notice period of 1 month on either side. In case of non-availability of candidates of the reserved category during selection process, selection of the UR candidates may be done against reserved seat for a tenure of 44 days subject to satisfaction of other conditions and eligibility criteria.

Note: 1 UR & 1 SC seat are for a tenure of 6 months & 1 UR and 1 OBC seats are for a tenure of 1 year. Reservation for PwD candidates will be as per government norms.

<u>Note</u>: No candidate will be allowed entry after 10.00 AM on 21st May, 2025.

Important Instructions:

1. All the interested candidates are required to submit application in the dully filled application form (as attached in Annexure A) from 9:00 AM to 10:00 AM on 21st May 2025 on the place mentioned above.

2. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post of Junior Residents in the Dentistry Department.

3. Reservation for the posts is applicable as per Government of India guidelines.

4. The Dean, ESIC Medical College & Hospital Faridabad reserves the right to vary these vacancies including increase or decrease or cancellation of filling up of any or all post without assigning any reason.

5. Change in date of screening test / interview, etc if any, will be intimated on website only. Candidates are advised to check the website regularly for any updated information related to the recruitment.

6. If the number of candidates applying for the post exceed five times the number of posts advertised, a screening test will be conducted. The test will consist of multiple-choice questions covering the dental subject's curriculum. The test constitutes a total of 25 questions and will have negative marking. Each correct answer will carry 4 mark and each wrong answer would carry 1 negative mark. The test will be of 30 minutes duration and candidates will be shortlisted for interview with 5 students on each vacant post having top marks.

7. The marks obtained in the screening test will not in any way be linked to the final selection process. The performance of the candidate in the interview will be the sole criteria for selecting the candidate for the post of Junior Resident (against GDMO). Mere participation in the screening test will not confer any claim for the vacant post.

General Terms & Conditions

1. The engagement will be for a tenure of up to 6 months (2 posts)/1 year (2 posts) only (maximum).

2. The Junior Residents (against GDMO) will paid remuneration equivalent to the Pay Level 10 of the 7th CPC i.e. a basic pay of Rs. 56,100/- per month and other allowances as applicable from time to time.

3. The engagement shall not confer any right or preference for the regular appointment.

4. The Junior Residents will be entitled for paid leaves of 2.5 days on per completed month of service. No claim for any service benefit like leave encasement, PF, pension, gratuity, medical allowances, increment, promotion, etc. will be admissible.

5. In case of appointment, tenure shall be terminable from either side with a notice period of one month in case of tenure of 1 year / 6 months and with a notice period of 4 days in case of tenure of 44 days.

6. Candidates in the Government Service shall submit "NO OBJECTION CERTIFICATE" from the current employer at the time of interview.

7. The candidates who are already employed must submit relieving order from the previous employer at the time of joining.

8. No TA/DA will be admissible for interview or joining.

9. Candidates applying for the reserved vacancies must possess the reservation certificate issued by competent authority (as per Government of India Guidelines).

10. The selected Junior Residents have to deposit security amount of Rs. 20,000/- (Rupees twenty thousand only) as Demand Draft in favor of ESI Fund Account No. 1 payable Faridabad. However, this amount will be appropriated towards administrative cost in case, the candidate resigns / terminates his/her

contract before completion of his/her tenure. The contract is liable to be terminated at any time without assigning any reasons thereof after giving one month's notice on either side or on payment of one month's emoluments in lieu thereof.

Eligibility criteria for Junior Resident in Dentistry Department

- 1. BDS Degree from an Institution recognized by the DCI.
 - 2. Candidate must have completed compulsory rotatory residential internship and must produce internship completion certificate at the time of interview.
- 3. Should have registered with DCI or Haryana State Dental Council.

Age Limit: Candidates up to the age of 30 year on the date of submission of applications. (Age relaxation of SC/ST/OBC/PH candidates as per Government of India rules in respect of vacancies reserved for them).

The relaxation in the upper age limit for OBC candidates is up to a maximum period of three years (03 years), for SC/ST candidates is up to a maximum period of five years (05 years), etc. No age relaxation would be applicable to SC/ST/OBC candidate applying for unreserved vacancies.

The candidates are advised to bring all Original Certificates and one set of self-attested photocopies of the following documents at the time of screening test & interview:

- 1. Application form (Annexure A) duly filled with passport size photographs affixed in the relevant place.
- 2. Identity proof (PAN card, passport, Driving License, Voter Card, Aadhar Card, etc.).
- 3. Address proof (Ration card, passport, Driving License, Aadhar card, etc.).
- 4. Certificate showing date of birth (10th class certificate or Birth certificate).
- 5. BDS certificate.
- 6. Registration certification with.
- 7. Compulsory Rotatory Residential Internship completion certificate.

8. Reservation category certificate (OBC/SC/ST/EWS, etc) in the format prescribed by Government of India. Self-attested certificate that the candidate has not done junior residency elsewhere previously(format attached)

9. NO OBJECTION CERTIFICATE, if applicable.

10. Demand draft for Fee* of Rs. 500/ in favor of ESI Fund Account No. 1 payable at Faridabad. Fee once remitted shall not be refunded under any circumstances.

Note*: Fee amount of Rs. 500/- is exempted for the candidates of SC/ST/PWD category and women candidates.
