- 1) The described unserviceable/scrap materials are lying at Staff Quarters, ESI Corporation, Sub-Regional Office Nagpur-440018 under physical possession of the Joint Director I/c, Regional Office Nagpur, ESI Corporation.
- 2) Sale/Auction will be in ONE LOT on "AS IS WHERE IS BASIS" and "WHATEVER THERE IS BASIS" and no guarantee for its worthiness or quality will be given by this office.
- 3) No items, once disposed of, from the successful vendor shall be taken back by this office on any condition whatsoever. Any uncleared or unnoticed materials left over by the purchases within the premises cannot be claimed later.
- 4) The vendor should conduct due diligence on all aspects related to the property to his satisfaction. The vendor shall not be entitled to make any claim against the Authorized Officer in this regard at later date.
- 5) The ESIC reserves the right to reject any or all offer/quotations for the said auction/sale without assigningany reason thereof.
- 6) The items shall be sold/auctioned to the highest vendor.
- 7) The purchase price shall be quoted in figure and words, in the schedule enclosed and in case of any discrepancy in price quoted in figures and words, the price written in words shall prevail.
