4. Earnest Money Deposit:

A refundable EMD of **Rs. 10,101/-** (Rupees Ten Thousand One Hundred and One Only) for Carton Boxes/ Paper items and **Rs. 5,279/-** (Rupees Five Thousand Two Hundred and Seventy Nine Only) for Plastic Items must be submitted by way of a Demand Draft/Banker's Cheque drawn in favour of "ESIC Savings Fund Account No. 1" payable at Hyderabad, before E-Auction. The bidder who does not submit the physical EMD will not be allowed in the E-Auction. The EMD of unsuccessful bidders will be returned without interest after the completion of the auction process. EMD in respect of the successful bidder shall be retained by this office upto 2 months after the contract end period.

- **5. Inspection of Material:** Interested bidders are strongly advised to inspect the Items at the designated location (ESIC Super Speciality Hospital basement) on the specified inspection dates before e-auction time. No claims regarding the quantity, quality or condition of the material will be entertained at the time of E-Auction. The scrap will be sold on weight basis on weekly/fortnightly basis.
- **6.** Reserve Price: The reserve price including GST for the Carton/Paper Items is fixed at Rs. 1,01,008/(Rupees One Lakh One Thousand and Eight Only) [i.e. @ 12318 kg for 2 years @ Rs. 8.2 per kg] and the reserve price for the Plastic Items is fixed at Rs. 52,788/- (Rupees Fifty Two Thousand Seven hundred and Eighty Eight Only) [i.e. @4399 kg for 2 years @ Rs. 12 per kg]. Bids below the reserve price will not be considered.
- **8. Acceptance of Bid:** The Medical Superintendent, ESIC Super Speciality Hospital, Sanathnagar, Hyderabad reserves the right to accept or reject any or all bids without assigning any reason thereof. The decision of the Medical Superintendent shall be final and binding on all bidders. The highest acceptable bid (equal to or above the reserve price) will ordinarily be selected.
- **9. Payment Terms:** The successful bidder shall make payment on weekly/fortnightly basis in accordance with the scrap collected from ESIC on weekly basis in the form of Demand Draft/Banker's Cheque in favour of "ESIC Savings Fund Account No. 1" payable at Hyderabad. Lifting of subsequent week shall not be allowed unless the payment of earlier week is settled. All applicable taxes (e.g., GST, etc.) shall be borne by the successful bidder as per prevailing government rules.
- **10. Lifting of Material:** The successful bidder shall be responsible for the complete removal and transportation of all scrap collected from ESIC on weekly basis at their own cost and risk. This includes providing their own labour, vehicles, and any necessary equipment.
- **11. Safety and Compliance:** The successful bidder shall ensure that all necessary safety precautions are strictly adhered to during the lifting and transportation of the material. The bidder shall comply with all relevant labour laws, environmental regulations and traffic rules. ESIC Super Speciality Hospital,

Sanathnagar will not be responsible for any injury, accident or damage caused to the bidder's personnel, vehicles or any third party during the process.

12. Forfeiture: In case the H1 (highest bidder) party fails to lift items within the stipulated period of 15

days, ESIC shall forfeit the EMD deposited without giving assigning any further reason.

14. Scrap Disposal: The bidder is responsible for all transportation, handling and lawful disposal

complying strictly with Central and Telangana State Waste Management Rules. Disposal must be eco

friendly and in accordance with the waste disposal guidelines issued by the concerned authorities. All the material must be vacated from ESIC Super Speciality Hospital while lifting material. No residuals be

left out in the premises of the Hospital. THIS BID IS MEANT FOR DISPOAL OF DAY TO DAY
